NOTES FROM THE EXECUTIVE DIRECTOR

In mid-July, I traveled to Mobile, Alabama to look over the conference site for the SMH meeting in March 2025. I had not been part of the original discussions, so everything was new to me. I flew cross-country to Pensacola and then to Mobile and landed late in the evening and drove to the main hotel at the Renaissance Mobile Riverview Plaza Hotel, not far from Mobile Bay. As expected, even in the late night, it was hot and humid, but a very pretty place with friendly people to greet me.

Periodically, when younger, I made the long trip by car from far West Texas to my mother's hometown of Brewton, Alabama (about an hour and half northeast of Mobile). We always traveled through Mobile, and I remember always finding it a beautiful city where we sometimes stayed for a night. I remember vividly as a high schooler visiting some of the historic sites with family members from Foley (right across the bay), especially the battleship, the USS *Alabama*. I also recall how good the seafood was, notably for a West Texan who thought Red Lobster was fine dining.

Today, Mobile puts itself right up there with New Orleans as a destination spot for the Gulf Coast. It is a remarkable city with so much history dating back to the Spanish and French, boasting it hosted the first Madi Gras Celebration in the area. Right near the conference hotel is the Colonial Fort of Mobile and not far away is the historic Dauphin Street. From a high perch in the hotel, you can see Mobile Bay where the famous naval battle occurred in August 1864. Only a couple of blocks away from the hotel is the famous bench where Tom Hanks pretended to be in Savannah for "Forest Gump." My favorite site remains the museum for the USS *Alabama*, one of the last *South Dakota* class battleships launched in 1942. Alongside is the USS *Drum*, a submarine launched in 1941 that served 14 patrols and sank 15 Japanese ships in the Pacific during WWII. To add to the wonderful historic charm, there are many great restaurants, especially seafood and Cajun and Creole food, most within walking distance of the hotels.

Now that we are only 180 or so days out from the conference, I want to encourage people to start planning on attending the conference as throughout the fall, we will have different reminders to you about getting rooms and registering. By early December, we should also have a finalized conference program (I know many of you have already submitted panels and roundtables). This massive undertaking has many components, but what matters most is that you have a great experience in a wonderful city with all your friends and colleagues from the Society for Military History.

CALL FOR PAPERS - SMH 2025

The Society for Military History announces a call for papers for its 91st Annual Meeting in Mobile, Alabama, March 27-30, 2025, at the Battle House Renaissance Mobile Hotel and the Renaissance Mobile Riverview Plaza Hotel.

The Program Committee's objective is to create a slate of panels that represent the breadth of expertise and interests as well as the overall diversity of the Society's wide-ranging membership. Individual paper and panel proposals on all facets of military history broadly defined will be considered for inclusion. Members in the academic community, the armed forces and governmental agencies, museums and archives, and independent scholars, as well as international members are encouraged to participate. Priority will be given to individual paper and panel submissions that highlight the presentation of original research, new interpretations, topics of immediate interest to our membership, and cutting edge trends and subject matter. Submission of Roundtables is encouraged; but preference will be given to panels that present new, original research.

All submissions will be judged on their merit using the above criteria.

Submission Instructions:

Individual paper proposals must include a 250-word abstract of the paper, and a one-page vita with contact information and email address. If selected, individual papers will be assigned by the program committee to an appropriate panel with a chair/commentator.

Panel proposals must include a panel title and 250-word abstract summarizing the theme of the panel; paper titles and a 250-word abstract for each paper proposed; and a one-page curriculum vitae for each panelist (including the chair and commentator) that includes institutional affiliation, email address, and other contact information.

Roundtable proposals must include a roundtable title, the full name and institutional affiliation of each participant, a 250-word abstract summarizing the roundtable's themes and significance, and a one-page curriculum vitae for each participant.

Members who wish to volunteer to serve as chairs and commentators should send a one-page curriculum vitae.

RUSSELL F. WEIGLEY GRADUATE STUDENT TRAVEL AWARDS

The Russell F. Weigley Graduate Student Travel Awards are given to outstanding graduate students to help defray costs associated with presenting a paper or roundtable at the annual meeting of the Society for Military History. The award provides \$1,000 to each recipient.

Only students whose proposal for a paper or roundtable has been formally accepted for inclusion in the program are eligible for these awards. *Students, may however, submit an award application before they are notified of their acceptance for the conference.* Applications will be evaluated based on the quality and originality of the proposed work and its likelihood to contribute to the development of the field of military history.

Applicants should submit a brief cover letter, curriculum vitae, and a copy of their proposed presentation for a panel or roundtable as a single document. A letter of recommendation from the student's primary academic advisor should be sent separately.

Applicants should be aware that this amount may not cover all travel costs. The committee does not consider financial need in making these awards. The number of awards varies each year.

Students enrolled in graduate programs outside of North America may also apply for the Jeffrey Grey Memorial Travel Grant. Applicants will be considered for both awards, but may receive only one in a given year.

Application material should be sent electronically to Holly Mayer (mayer@duq.edu). The application deadline is **December 5, 2024.** Awards will be announced by early February 2025. Awardees will be honored at the Society's awards dinner and will receive a complimentary ticket to that event.

JEFFREY GREY MEMORIAL TRAVEL GRANT

In honor of the late Dr. Jeffrey Grey, the Society for Military History is pleased to award the **Jeffrey Grey Memorial Travel Grant**. This grant will be awarded to an outstanding graduate student who is enrolled in a graduate program located outside of North America. Funds are intended to defray costs associated with presenting a paper or roundtable at the annual meeting of the Society for Military History. Applicants must indicate that they **do <u>not</u>** currently reside in North America.

The award will not exceed \$3,000 and will be based on a reasonable estimate of the cost of travel, accommodation, and registration.



2024 SUMMER SEMINAR IN MILITARY HISTORY

This July, sixteen early career scholars and advanced doctoral candidates gathered at Virginia Military Institute for the 2024 SMH-VMI Summer Seminar in Military History. Over the course of three weeks, the 2024 fellows undertook a proverbial march through key scholarship on modern military history, chased documents in the VMI and George C. Marshall Foundation archives, and put their rigorous historical training to practice on a staff ride across the Civil War-era New Market battlefield.

Under the direction of Dr. Bill Allison, Professor of History at Georgia Southern University, the seminar sought to "better prepare [fellows] for teaching courses in military history, war and society studies, and other related fields," with a special emphasis on "operational military history, war theory, studies in war and society, and the history of military institutions," per the seminar's syllabus. Dr. Allison was joined each week by a co-director (Dr. Susannah Ural, Professor of History and Frank and Virginia Williams Chair for Abraham Lincoln and Civil War Studies at Mississippi State University; Dr. Jennifer Keene, Professor of History and Dean of Wilkinson College of Arts, Humanities, and Social Sciences at Chapman University; and Dr. David Kieran, Associate Professor of History and Colonel Richard R. Hallock Distinguished University Chair in Military History at Columbus State University). Additionally, twelve visiting scholars—ranging from history professors to museum and archive directors—treated the fellows to a series of lectures, workshops, and guided tours. "It's two things," said Dr. Allison. "It's picking a good group of fellows, but it's also inviting a really good group of visiting scholars. It's getting the right people to do that—and I think we nailed that."



Daily activities introduced the fellows to a broad swath of military history from the colonial period to the present. "The SMH Summer Seminar and Director Allison provided an ideal environment for learning about the main currents of military history and helped to foster a tight-knit fellowship among the junior scholars in attendance," said Cody Billock, PhD candidate at Ohio University. Among topics related to U.S. military history, the seminar exposed fellows to such themes as Napoleonic warfare and Clausewitzian thought; the wider global contexts of the World Wars in Africa and Asia; and how to approach subfields like the histories of race, gender, and memory studies. Beyond traditional lectures that provided fellows with the fundamentals to teach wars outside their area of specialization, the visiting scholars frequently touched on pedagogical techniques. Among other activities meant to enrich students' understanding of and engagement with different historical time periods, the fellows practiced drafting letters of last resort as part of a lesson on nuclear strategy and debated the precise definition of "war" when prompted by photographs of different armed conflicts. These served as blueprints for fellows to take with them back to their own classrooms. "I think it helped bring people into the field who are, say, military history-adjacent," said Dr. Allison, "and to really start to think of themselves as military historians. It gave them breadth to prepare for teaching military history courses of all sorts."

The seminar's first weekend saw the group embark on a staff ride at the New Market battlefield. The fellows learned to read military maps and analyzed the terrain up-close, envisioning how the changing landscape might have looked 160 years earlier as they peered over the rolling hills at a Burger King that stood where a battery of U.S. artillery once sat. After the formal tour concluded, some fellows toured the nearby Virginia Museum of the Civil War while others set off to analyze the same battlefield from the perspective of United States forces on the other side of the terrain. Later, the fellows pored over maps in the VMI Archives and examined historical artifacts firsthand in the basement collections of the VMI Museum. Many of the fellows similarly found time in the evenings to conduct some work for their own scholarship at the George C. Marshall Foundation, which was generously kept open after hours for the seminar's fellows by Director of Library and Archives Melissa Davis.

Such a wide-ranging expanse of coursework and extracurricular activities made the Summer Seminar in Military History an experience as engaging as it was enriching for the fellows. The group benefited tremendously from the variety of academic interests and methodological perspectives that each fellow brought to the table, with expertise in the military histories of North and South America, Europe, Africa, and Asia all represented by at least one fellow. The seminar served as an excellent networking opportunity for all involved. The camaraderie forged in the seminar's fires has already led to plans for peer review and collaborative work, including several panel proposals for the upcoming 2025 SMH Annual Meeting in Mobile. "It's a lot of work, it takes a lot of people to put it together, a lot of time, and there are a lot of moving parts," said Dr. Allison. "But once I saw the fellows together at the opening reception on that Sunday night, I said, 'We're going to be fine.' I knew right then."



JAMES C. BRADFORD (1945-2024)

On August 11, 2024, the military and naval history community lost one of its most longstanding and prominent members, James C. "Jim" Bradford. He was 79 years old.

Jim was born in Detroit, Michigan, but was raised in Traverse City. He earned his B.A. and M.A. from Michigan State University before moving on to the University of Virginia for his Ph.D. He completed his dissertation, "Society and Government in Loudoun County, Virginia, 1790-1800," in 1976 while working with noted early American scholar William W. Abbott. Prior to earning his Ph.D., Jim accepted an appointment to teach at the U.S. Naval Academy in 1973 where he remained for the next eight years.

In 1981, Jim accepted an appointment to the faculty at Texas A&M University where he would remain for the rest of his career, save for two visiting professorships at the Air War College from 1995 until 1997 and as the distinguished Class of 1957 Chair of Naval Heritage at the Naval Academy during the 2012-2013 academic year. Over the next three-plus decades, he authored and edited numerous volumes in naval and military history, including a trilogy of volumes published by the Naval Institute Press subtitled *Makers of the American Naval Tradition: Command Under Sail* (1985), *Captains of the Old Steam Navy* (1986), and *Admirals of the New Steel Navy* (1990). He also edited the papers of John Paul Jones in 1986. He also authored the naval history textbook *America, Sea Power, and the World* (2016) that remains the standard text for the naval history survey course at the Naval Academy.

His commitment to teaching and service were unwavering. During his career, Jim became involved with numerous professional organizations, including the American Military Institute prior to its transition to the Society for Military History in 1990. He also served in the International Commission on Military History, a found member of the Society of History of the Early American Republic who also served as its executive director from 1996 until 2003, and as the president of the North American Society for Oceanic History from 2007 until 2009.

Jim was a committed teacher and mentor whose deep knowledge stimulated aspiring historians. While at Texas A&M, he taught a variety of courses, including undergraduate and graduate courses on naval and military history. He also became heavily involved in the university's study abroad program, routinely taking students to Europe and the United Kingdom during the summer months to allow them to further enrich their study of history. Those who participated in the program returned with a bounty of knowledge and a wealth of treasured memories.

His keen eye for detail and editorial efficiency made him a demanding mentor, but it was a deeply rewarding experience for those who accepted the challenge. During his tenure, Jim advised ten Ph.D. students, many more master's students, and served on dozens of committees. Speaking personally as one of his students, his willingness to support his students carried over long after the degree was earned. For years thereafter, he continued to offer sage and practical advice to navigating the ever-perilous academic job market and wrote sterling letters of recommendation, all with the goal of seeing that his students found the positions they desired.

He retired and entered emeritus status in 2016, although he remained active in the field for some time thereafter, continuing to attend conferences until 2019 when his health began to fail and only

participating in his last dissertation defense in 2020. With assistance from his son John, who himself earned his Ph.D. from King's College in 2024, Jim completed a second edition of *America, Sea Power, and the World* in 2022.

Almost anyone who interacted with Jim in person encountered his sense of humor. For his students, receiving a BAFL—Bradford's Advice for Life—at the beginning of class or seminar was a special treat, with Jim dispensing valuable advice, including that they "Never fry bacon in the nude." Jim also showcased his wit amongst his peers, suggesting during the process of renaming the American Military Institute that the organization rename itself the Society for Military, Air, and Sea History (SMASH). One could easily fill a volume with his humorous quips and anecdotes.

Jim's humor combined with his equally well-known diligence and generosity made him a peerless colleague, mentor, and friend, and one whose presence has been sorely missed in the community. Yet Jim's spirit will live on as his work has helped to stimulate interest in naval history among a new generation of scholars, and it is fitting that NASOH awards a dissertation research grant annually in his name.

Jim is survived by his wife Judy and his sons John and Jim.

In choosing the theme of "Power and Agency," the conference seeks to promote a scholarly discussion of ways that past individuals and the decisions they make have impacted the course of history. This theme may be interpreted broadly to include papers focusing on the impact of individuals from all backgrounds, circumstances, or time periods.

This includes papers examining examples and the consequences of agency practiced by social elites, such as politicians, generals, and business leaders, as well as traditionally marginalized actors, such as the working class, migrants and immigrants, and racial, gender, or sexual minorities. While the conference theme seeks to highlight individual agency, we also encourage papers that examine the broad historical forces that influence individuals and the decisions they make.

Undergraduate and graduate students interested in presenting at the conference must submit a 250-word (maximum) abstract, along with a curriculum vitae (CV), by Friday, November 22, 2024.

Notifications of acceptance will be sent via e-mail by mid-December. Accepted presenters will have until Friday, January 24, 2025, to submit completed papers, not to exceed ten pages.

Completed panels are welcome and not required or expected.

Awards in recognition of excellence will be presented to the best overall Ph.D., M.A., and undergraduate papers. Travel grants will be awarded on the basis of merit and documented need.

The Military History Consortium (MHC) will be holding its second annual conference on 4-6 June 2025 at Iscte-University Institute of Lisbon in Lisbon, Portugal. The organising committee invites panel and individual paper proposals on any aspect of military history and the history of war and conflict in its broadest sense, ranging from ancient to modern times and spanning the entire globe. This includes the cross-chronological interactions between political, economic, social, and cultural history with military history. In line with the MHC's aims, panels and papers that cover periodically and geographically under-represented areas (e.g. Antiquity and the Global South) are especially welcomed. A key aim of the MHC is also to provide a platform for and support the development of early career scholars, and therefore submissions from PhD students and postdocs are strongly encouraged.

Panel proposals should consist of:

- 3 papers and 1 chair/discussant
- 500 words rationale and presentation of the panel
- 300 words abstract for each paper
- 150 words short bio for each contributor

Individual paper proposals should consist of:

- 300 words abstract
- 150 words short bio

The submission deadline is **15 December 2024**. The organising committee will inform potential participants on whether or not their paper/panel has been accepted by 17 January 2025.

Topics may include, but are not limited to, Midwestern attitudes toward extensive American involvement in foreign affairs during the Cold War decades; the development of military bases and the installation of nuclear weapons in the Midwest; the role of ethnic groups from the captive nations in domestic politics (Poles, Hungarians, Ukrainians, etc); the experience of Midwesterners in the US military who served in Cold War zones; Midwestern heavy industry and the creation of the American arsenal; the influence of Cold War imperatives on the Civil Rights movement (i.e. the Brown decision); the role Midwestern diplomats such as George Kennan; political leaders skeptical of Cold War interventionism such as Robert Taft and John Bricker; the Vietnam war and the Midwest; Midwestern patriotism in a Cold War context; Midwestern conservatism and its role in American anti-Communism; campus protests and the Midwest; the role of Joe McCarthy of Wisconsin and similar anti-Communist political leaders; the role of groups on the progressive left and opposition to Cold War policies; the culture of the Cold War and domesticity; civil defense and bomb shelter construction; anti-Communist churches and religious leaders in the Midwest; the movement of Southeast Asian refugees to Iowa and Wisconsin and other Midwestern places; how the Cold War was experienced differently in the Midwest than other regions; the influence of religion in the Midwest during the Cold War era; films and literature which connect the Cold War and the Midwest.

'Rethinking Concepts, Terms and Topics'
The 4th International Conference of the Military Welfare History Network
July 9-11, 2025 at the University of Graz, Austria

Approaches to military history and the history of war welfare have changed fundamentally in recent decades. They shifted from a focus on event history, the depiction of predominantly operational levels, the monopolisation of military meanings or discourses of legitimation to innovative approaches to a cultural history of armed conflicts, which are particularly influenced by Social History, the History of Mentalities, Body or Gender history. This also applies in particular to the analysis of military welfare

and care practices from a historical and social science perspective, which has undergone a fundamental reorientation in recent years, not least as a result of current care ethics debates.

The fourth international conference of the Military Welfare History Network, which will take place for the first time at the University of Graz (Austria) in 2025, aims to explicitly focus on the theoretical, conceptual and research-practical dynamics associated with this reorientation. The conference aims to reflect about these changes in studies of care and welfare practices in military contexts and to discuss older and new concepts and their implementation in research. Referring to a problem-orientated approach, an explicitly interdisciplinary and trans-epochal orientation will be taken.

The aim of the MWHN conference is therefore to critically examine the effects of theoretical and conceptual perspectives as well as the productive applicability of (new) methods and concepts on different dimensions:

- the macro-level (state-national, transnational or global relations and networks, civil society and corresponding symbols, norms and orders etc.)
- the meso-level (such as the history of institutions and organisations as well as interdependencies between economic, political, societal, cultural and military issues)
- the micro-historical relationships (self-testimonies, personal identities, biographies etc.) in war care and welfare practices

Discourses, socio-cultural negotiation processes, the distribution of and access to socio-cultural resources, covert or overt power relations and hegemonies that form their background should be addressed as well as dimensions of experience and, in general, research desiderata and gaps in previous scientific approaches.

Submissions with either a theoretical-methodological or conceptual focus or empirical case studies are welcome. In both cases, the submitted contributions should address both levels (albeit with different emphases). In this way, the exchange of concepts and perspectives, mutual interaction possibilities and the intended discursive character of the conference should be promoted.

In particular, the following topics can be addressed:

- Vulnerability | Trauma | Violence
- Belongings | Identities | Interdependencies | Diversity | Social entanglement
- Spaces | Boundaries | Transgression
- Body | Sexuality | Gender

Each paper abstract should be a maximum of 250 words and should be accompanied by a 50-word biography. Panels should also include an additional 'panel abstract' of up to 250 words.

War and Revenge

Dr. Martin Göllnitz, Marburg University Prof. Dr. Dr. Frank Jacob, Nord Universitet

Emotions often determine the path towards conflict as well as the actual war itself. The wish for revenge is a central element in this emotion-driven relationship and often impacts the views of the combattants, but also the experience of the victims of violence during wars. The memory and the respective commemoration of a violent past is thereby also very often determined by a sense or wish for a supposedly necessary form of revenge. The interrelationship between war and revenge is therefore an important subject for a more detailed analysis.

The legal concept of 'retribution' plays a central role in the thematic field of 'war and revenge' and often represented a key legitimisation strategy for atonement measures. By claiming the right to 'atone,' i.e. to punish, it was possible for the actors to feel that they represented a power that claimed the right to establish a new order. Violence was thus based on a 'subjective sense of action,' which was intended to ensure stability and at the same time appeal to a socially widespread, metaphysically anchored sense of justice. Damage was to be inflicted on the opponent in at least the same way or with the same effect as that for which the opponent himself was responsible. This gave retaliation a dynamic factor: by reversing the responsibilities, justifying one's own violence with a threat and interpreting it as preventive self-defence, one's own de-limitation of violence could be declared legitimate and necessary.

For a volume in Brill/Schöningh's series War (Hi)Stories (https://brill.com/view/serial/WHS) this call, which is open with regard to time period and geographical region, is directed towards scholars at any career level who work on revenge and war in all possible related contexts, including, but not limited to, the following aspects and questions:

- Revenge and the path to war: Which role does revenge play with regard to pre-war politics and strategic war plans? How does the wish for revenge create a certain legitimation for war?
- How is revenge and violence during war actually legitimized? Which narratives or strategies are applied to justify retaliatory or penal measures of extreme violence?
- How does the sense of revenge determine the relationship between perpetrators and victims in a war related context?
- How is revenge related to the memory and commemoration of war as well as a possible element in the preparation of the next violent conflict?

Short proposals (ca. 250-300 words) and a short bio should be sent to <u>martin.goellnitz@uni-marburg.de</u> and <u>frank.jacob@nord.no</u> until **October 31, 2024**. Final papers, ranging from 7,500-10,000 words,

including footnotes (following the latest Chicago Manual of Style) but excluding references, are expected by March 30, 2025.

The Many Faces of War X: An annual hybrid interdisciplinary conference on the experience and impact of war throughout history.

2025 Theme - The Consequences of Conquest in honor of the 80th anniversary of the end of World War II we will examine what happens after a defeat or a victory in war, conflict, or battle.

General Omar N. Bradley Fellowships in Military History

Each year the General Omar Bradley Foundation offers \$2000 research fellowships to up to ten Army officers engaged in research related to military history. The Omar Nelson Bradley Fellowships selection committee consists of members of the Department of History of the United States Military Academy appointed by the Professor and Head, Department of History, United States Military Academy. Selection of the Fellows will be made without regard to rank, branch, or affiliation with the USMA Department of History. Funds will be granted to those officers who are actively engaged in original, archival historical research (including digital humanities research and digital research in archival sources) and have the best developed plans for conducting significant historical work. Research should be in pursuit of a graduate degree or scholarly publication. The committee will recommend a slate of ten proposed Omar Nelson Bradley Fellows to the Directors of the Omar Nelson Bradley Foundation by January 15, 2025 with the aim of a final announcement of recipients by February 15, 2025.

Who May Apply. U.S. Army officers who are actively engaged in the study of military history. Reserve officers may apply, but preference will be given to individuals on active duty. "Active engagement in the study of military history" includes research toward a master's degree or doctorate in military history or research toward a scholarly article or monograph in military history, and can include digital humanities projects (the creation of databases, map collections, and the like).

The selection committee interprets "military history" in the broadest sense. Projects supported in 2024 included Crusading ideology and rhetoric outside the Mediterranean Crusades; the U.S. Army's reactions to the First World War before 1917; the Russian Civil War battle of Tsaritsyn; U.S. armor in the Second World War; U.S. aid to China during the Second World War; the U.S. intervention in the Dominican Republic in 1965; Tom Clancy and U.S. national security; the use of military power by the UN; the Signal Corps during the 1990s and 2000s; and the U.S. Army Asian Studies Detachment in Okinawa.

Officers who have been awarded a fellowship in the past may apply again. In such cases, the officer should indicate the receipt of the previous grant and how it was employed, including any publication (or degree thesis) to which it contributed.

How to Apply. Officers meeting the criteria above should apply to Professor Samuel Watson, Chair, Omar Nelson Bradley Fellowships Committee, electronically at samuel.watson@westpoint.edu, or Professor Samuel Watson, Chair, Omar Nelson Bradley Fellowships Committee, Department of History, United States Military Academy, West Point, New York 10996. The committee strongly prefers electronic applications. These may consist of a single PDF or several documents, but should be sent in a single email. Applications are due by January 1, 2025.

Letters of application should include:

- name, rank, e-mail address, surface address (we will need this to send your check if you are selected), phone number, and duty position of the applicant;
- the objective of the proposed research, progress of research to date, any distinctive methodology to be used, a specific statement of needs for funding (for example, specific archives or

- collections to be examined, and costs expected to be incurred in doing so), and the proposed method of publishing or disseminating the results of the research. Note that microfilm, PDFs, or other downloads can be purchased with this funding.
- Additional materials that will assist the committee in evaluating the application may also be submitted: letters of recommendation, preferably from scholars (for example, thesis or dissertation advisers, or other scholars who have read your scholarship) and writing samples (of no more than chapter or article length) are recommended. Curriculum vitae (for those working on a post-dissertation project) may be valuable. (You may also note any previous scholarly publications, or those under review or accepted for publication, in your application letter.)

 Transcripts, ORBs, and OMPFs are unnecessary. Applications are due by January 1, 2025.



The National WWII Museum invites applications for the Faculty Seminar in World War II History to be held in New Orleans, Louisiana, from June 15-21, 2025.

This weeklong intensive study is designed for any college-level instructors or professors who desire a stronger historical background in the American experience in World War II. Particularly, we encourage applicants from under-resourced and smaller colleges and seek to enhance the faculty at Minority Served Institutions (MSIs) and Historically Black Colleges (HBCUs). In addition, the program is available for Professional Military Education (PME) institutions and Reserve Officer Training Corps (ROTC) instructors.

This seminar is intended to develop the knowledge and understanding of World War II for active college or university faculty who wish to teach, advocate, or design history courses and content regarding this significant conflict.

The program consists of a series of content and pedagogical seminars led by the Museum's expert faculty covering the war's major themes, campaigns, outcomes, and legacies. Lodging for six nights, select meals, and course materials are provided. Travel costs to and from New Orleans are the responsibility of the attendee or their institution.

A limited number of travel grants will be available on a case-by-case basis. If you are unable to obtain financial assistance from your institution and would like to be considered for a travel grant, limited funds may be available. Further information on such requests will be made available upon acceptance.

Applicants will be selected based upon their potential contributions to the teaching of WWII history and the impact they can make on their institutions. The program is open to all college-level faculty, PME, and ROTC instructors who expect to teach or study military history or American history focused on World War II. A selection committee will consider each applicant's packet on its own merits.
