Dear Society Members:

Following the successful use of the model format by the AHA for late breaking and urgent topics, the SMH invites panel and roundtable submissions for a limited number of sessions that place contemporary military and strategic events—including but not limited to conflicts in Ukraine, Syria, Gaza, and Sudan; tensions in the Pacific; the impact of changing political administrations on civil-military relations; and the use of emerging technologies in warfare -- within the context of military history. We will only accept full panel and roundtable submissions for consideration (not individual submissions) for these additional panels with a late-breaking nature to contribute to our understanding of complex issues. The deadline for submissions will be **January 27th at 11:59 CST**.

Please submit your full proposals in one PDF document to smhconferences@gmail.com.

Submissions should include:

- Session title (of no more than 20 words)
- Session abstract (up to 500 words)
- Short session abstract for the meeting app (up to 50 words)
- Panel and roundtable titles
- Abstract or description for each presentation on the panel (up to 300 words); not required for roundtable submissions
- Biographical paragraph or CV summary (up to 250 words) for each participant
- Correct e-mail address for each participant
- Affiliation, city, state, and country for each participant

Acceptances will be sent out by February 1st and accepted participants should be prepared to make short notice travel plans.

2025 GEORGE C. MARSHALL LECTURE

The SMH's committee to select the speaker for the annual George C. Marshall lecture at the AHA had selected Richard J. Overy as the 2025 speaker. He is currently an Honorary Research Professor at the University of Exeter, with a long and distinguished career writing about World War II. His talk, "Ending World War Two: Germany, Japan, and Surrender, 1945" partly comes from his forthcoming book *Rain of Ruin: Tokyo, Hiroshima, and the Surrender of Japan*. His summary of the talk noted that eighty years ago Germany and Japan in different ways accepted the Allies' demand for unconditional surrender. But before that both armed forces continued to fight to the bitter end despite battlefield defeat and the destruction of the urban homeland. The lecture compares these two end-games and the Allied response to their enemy's unwillingness to capitulate.

Unfortunately, Dr. Overy's plane to New York City was diverted due to an on-board medical emergency (not his!), he was unable to attend the AHA, and they lacked the facility for a Zoom talk. Following our backup plan, Wayne Lee, VP of the Society and chair of the Marshall selection committee, stepped in and gave a lecture based on his 2023 book, *The Cutting-Off Way: Indigenous Warfare in Eastern North America*, 1500-1800. We were able to circulate word at the AHA and on social media about the change, and some sixty-seven people attended, with only a few still surprised at the change of topic! There was a lively Q&A that lasted for some 40 minutes.

Afterwards, the SMH leadership decided to offer a "keynote" slot at the SMH conference in Mobile to Dr. Overy, which will be delivered via Zoom on Saturday, March 29 from 12:00-1:30 pm to a conference venue. I am very much looking forward to it.

CALLS FOR PAPERS AND CONTRIBUTORS

Call for Papers

Dominican University New York cordially invites historians, scholars, and educators to its International History Conference on World War II in honor of the 80th anniversary of the ending of that conflict. Located about midway between New York City and the U.S. Military Academy-West Point campus along the scenic Palisades Parkway and surrounded by historical sites spanning the Colonial Period to World War II, Dominican University provides a convenient and historically relevant site to gather for this special event. Its campus was once part of the sprawling Camp Shanks, which served as the U.S. Army's largest embarkation point for Soldiers heading to the European Theater of war. For those who shipped off to war from this military base, it became known affectionately as "Last Stop USA." Approximately 75% of the Soldiers who participated in the Normandy invasion known as D-Day passed through Camp Shanks. Late in the war and during the months that followed, the base processed nearly 300,000 German and Italian prisoners of war before it was decommissioned in 1946 and converted into public and private development. Dominican University's campus was part of this post-base development.

Call for Papers:

We welcome paper and panel proposals across the full breadth of topics and issues relating to the greatest conflict in world history on the 80th anniversary of its conclusion. We particularly welcome proposals on the following topics:

- Strategy, tactics, innovation
- Alliances and international relations
- Homefront
- Politics and propaganda
- Holocaust and displaced persons
- Peace settlements, reconstruction, renewal
- Legacies and lessons learned
- Military studies and pedagogy

Graduate students are welcome to apply. We are accepting two types of proposals, individual papers and panel discussions:

- 1. Paper proposals must be in the form of an abstract of no more than 300 words, a mini-abstract of 50 words or less that can be used in the conference program, a title of 25 words or less, a short author bio of no more than 100 words, and a list of 3-5 keywords. A standard paper session will run for 25 minutes with 5 minutes allotted for questions and answers.
- 2. Panel proposals must include three presenters with a moderator. Each presenter must submit a 300-word abstract, a mini-abstract of 50 words or less that can be used in the conference program, a title of 25 words or less, a short author bio of no more than 100 words, and a list of 3-5 keywords. Each presenter will be allotted 20 minutes after which the presenters may respond or

ask questions of others. After this, panel moderators may open up the questions and discussion to include the audience.

Tentative Schedule:

- 28 May Registration and Evening Reception
- 29 May Key Keynote Address/Paper and Panel Sessions
- 30 May Paper and Panel Sessions
- 31 May Optional tours to New York City or U.S. Military Academy-West Point Campus

Registration Fee and Lodging:

The early registration fee is \$149 per person if paid by Friday, 28 February 2025. The standard registration fee of \$189 per person will apply if paid after 28 February. The registration fee includes the evening reception on the first evening of the conference, breakfast, lunch, and coffee service during both day sessions of the conference. The rates for graduate students are \$99 for early registration and \$139 for regular registration after 28 February.

On-campus lodging is available for an additional fee. Single rooms with single bathrooms are \$100 per night, and double rooms with a shared bathroom are \$50 per night. A conference discount also is available at nearby hotels at approximately a 10% discount from prevailing market rates. Please contact the conference organizers for assistance with off-campus lodging.

Registration fees may be paid online at https://www.duny.edu/history-conference/ using the digital payment function or paid by checks made out to Dominican University New York. The physical mailing address is listed at the end of this announcement.

Optional Tours:

To facilitate exploration of the rich history and culture of the Lower Hudson Valley, we have organized two optional tours for Saturday, 31 May. Tours are provided by third-party vendors and are subject to market rates as the dates of the conference approach. We anticipate the following ticket fees for each tour: \$125 for New York City and \$60 for West Point. Please note that West Point remains an active military post. Special security protocols remain in place.

Military Welfare History Network

'The Military Medicine and Welfare of the First World War: preparations, evolutions and legacies'

Date: Thurs 10 – Fri 11 April 2025

Venue: Muirhead Tower, University of Birmingham

Overview

In August 1914, several global empires marched into the world's first total war of the twentieth century with their nineteenth-century armies. In support of those land, sea and later air forces were medical and nursing units, corps and services, as well as transportation divisions and infrastructures, which, along with medical, convalescent, state welfare and private charity infrastructures and traditions on their home fronts were wholly unprepared for the onslaught they would face.

Taking the First World War era as a case study, this event will look at the welfare, care and medical provisions afforded to service personnel, their families and other dependents – military welfare – before, during and after the conflict. In doing so, it seeks to both build upon and bring together the plethora of research produced by scholars around the globe on topics such as army doctors and nurses; medical transportation, technologies and infrastructures; state benefits; charity; pensions; rehabilitation and care; trauma and memory; migration; and gendered dimensions to military welfare.

Papers are invited that look at:

- 1. what healthcare and welfare provisions were in place going into the war in all belligerent and non-belligerent states, nations and territories;
- 2. how or if these developed during and after the war;
- 3. how or if they continued to evolve after 1918 or if they ceased to exist;
- 4. how the study of military welfare benefits from comparative and transnational approaches;
- 5. how the recent centenary of the First World War influenced existing scholarship on military welfare and the potential to explore and implement new concepts to advance the historiography;
- 6. how of if contemporary military healthcare and welfare provisions and programmes can learn from the developments and experiences of the First World War era?

All of this will be set and viewed within the broader context of the military welfare history 'perspective'. As a result, the convenors welcome submissions focusing on earlier conflicts, if military welfare during the conflict acted as a precursor to the First World War, and later conflicts, if aspects of their military welfare had a legacy from the Great War.

While some previous conferences relative to the First World War have focused on a constituent part of military welfare history, this symposium will be the first to engage with this diverse field in its entirety. In doing so, it seeks to provide a forum for multidisciplinary knowledge sharing, cross-pollination and constructive scholastic debate.

We request submissions to <u>militarywelfarehistory@gmail.com</u> by Friday 14 February 2025. Individual papers or panels can be submitted. Panels should comprise three papers and submit a panel abstract as well. Abstracts should be no more than 250 words per paper and should be accompanied by a 50-word biography for each presenter.

The conference will be streamed live to registered online attendees and several of the papers will be recorded and hosted on an established podcast series. This event is free to attend, but please book your place via militarywelfarehistory@gmail.com, if you are not presenting.

Harvard Global Vietnam Wars Studies Initiative (GVWSI) 2025 Conference Fifty Years On: New Perspectives on the Vietnam Wars

Fifty years have passed since North Vietnamese tanks rolled into Saigon in 1975, after decades of setpiece battles, guerrilla warfare involving a dozen combatant nations, and overlapping civil conflicts in Vietnam, Laos, and Cambodia. Although vigorously debated in the United States, the war's meanings and implications remain unresolved. Vietnamese and other international perspectives are rarely studied, as most current research focuses primarily on American perceptions, experiences, and memories. As a result, we still struggle to tell the broader tragedy of the conflict, even as its ashes and embers continue to spread across the globe and through generations.

Content Priorities

This conference, organized by the Global Vietnam Wars Studies Initiative at Harvard Kennedy School, seeks to bring together informed assessments from around the globe to provide an evidence-based, indepth exploration of this multifaceted war and its complex legacies. We invite proposals on the following themes:

- New assessments of the war itself— in its human, social, cultural, religious, economic, political, psychological, diplomatic, civilian, and military dimensions, including how these analyses have evolved since 1975.
- Insights from the communist bloc and non-communist allies, illuminating how different sides perceived victory, defeat and the enduring impacts on national identities.
- Analysis of lessons learned by Vietnam, the U.S., and other former allies and adversaries, examining how these experiences have shaped policies, military strategies, and power structures over the past five decades.
- Examination of how the war continues to challenge participating countries in their process of healing, reconciliation, and addressing war legacies in nation-building.
- The role of migration and the Vietnamese diaspora, focusing on their experiences and contributions, as well as their impact on the political, economic, and cultural landscapes of their new countries.

A deeper understanding of the wars' global impact is vital for history and is also timely and essential for addressing current and future conflicts. Above all, we seek to foster intellectual, historical, and cultural exchanges across nations, communities, and generations, with a shared commitment to scholarship, reconciliation, and healing.

We invite scholars, researchers, veterans, and practitioners from around the world to submit paper proposals.

Our aim for bringing together these global viewpoints is to begin to bridge the gaps of the last half-century and offer new directions for future research and teaching on the Vietnam Wars and beyond.

WWII Emerging Scholars Symposium

The Eisenhower, Roosevelt, and Truman Presidential Libraries invite emerging scholars to submit a presentation abstract to be a featured speaker during the annual D-Day Commemorative Symposium. The 2025 symposium will be held the first week of June and the theme is A Salute to Veterans.

Following WWII, many veterans sought a smooth transition to home life. For some of these veterans, they soon found themselves to be unwelcomed, discarded, and forgotten. As a result, organizations like AMVETS and other advocacy groups were established. This year's scholars are encouraged to examine lesser-known veteran demographics, fraternal orders, military clubs and activities created from these shared experiences. These topics can range from groups such as Atomic Veterans to the informal brotherhoods and sisterhoods of marginalized servicemen and women.

This virtual symposium focuses on specialized topics related to the Allied effort during World War II. Each presentation is approximately 40 minutes and the program wraps up with a Scholar Spotlight where we get to know a little bit more about each of these up and coming scholars.

The RAF Museum seeks proposals from postgraduate students, early-career and established researchers for our 2025 Research Lecture Programme. Lectures will be hosted online and at sites in London and the Midlands, and will share new research being undertaken in the fields of Air Power, aviation history and histories of air forces. The lectures enable those interested in these fields of study to share their knowledge, and to highlight the interdisciplinary approaches and research methods being utilised.





The Linda Hall Library holds nearly half a million monographs and more than 43,000 journal titles documenting the history of science and technology from the 15th century to the present. Bill Allison Personal Statement

I have been active and a strong supporter of the SMH for my entire academic career and owe much of what I have accomplished and many of the professional opportunities that have come my way to my involvement in the SMH. Over the past thirty years, I have, like many others, both witnessed and helped facilitate the tremendous growth of the SMH conferences – not only in size but in the diversity of presenters and topics presented. The SMH membership has also changed, dramatically so. The organization has also undergone tremendous changes in how it operates and manages this growth, and it stewards the remarkable diversity of "what is military history." So many outstanding people have volunteered their time in such a range of capacities throughout this time – without them, the SMH would not be where it is today. Still, challenges present themselves. The annual conference is becoming more expensive to put on and attend. The costs required to staff the SMH have increased. There are questions about the future of the Journal of Military History. While the participation of women in the discipline has grown substantially over the past twenty or so years, the representation of diverse voices in the field remains unrealized despite some movement in the right direction. The SMH has undertaken discipline-specific initiatives to promote the future of military history, such as bringing back the Summer Seminar, in which I have had the privilege to be involved. SMH leadership needs experience and new perspectives to successfully manage these challenges. My decision to stand for a return to the Board of Trustees is grounded in my experience with the SMH over the past thirty years. I can bring that experience to the table, just as newer members can bring fresh perspectives. This combination, I believe, can help steer the SMH to continued success over the next decade.

Marion (Molly) Girard Dorsey is a professor of History, core faculty (and former holder of the Lamberton Professorship) in the interdisciplinary Justice Studies program, and core faculty in the Medical Humanities, Society & Ethics minor at the University of New Hampshire (UNH). Biography for Ben Jones

I grew up in South Dakota and received my history degrees from public universities on the Great Plains. I've seen much of the world, including nations enduring decades of war and those that have suddenly erupted in violence. Over the years I became keenly interested in what has prompted noncombatants to take up arms. Much of the answer to that issue lies in how culture provides the framework for people's choices. So even though my publications deal with people as varied as the French, the Afghans, and the Lakota, they have all centered around how culture drives notions of what's worth fighting for. My second tour in Afghanistan included collaborating with senior Afghan officers to help determine their path to taking over responsibility for the war. In that light, I applied some of what I learned about how cultural differences set the tone and limitations for our work. In recent years I've worked to create stronger K-12 history education in my home state. To that end, as my state's Secretary of Education and now as a public historian I spent a large part of my efforts creating stronger social studies standards and productive professional development to better equip K-12 teachers. I now enjoy helping audiences understand their state's complicated history, designing our new state museum, and hosting a podcast, History 605, which focuses on how people explain the past. I look forward to bringing my skills and experience to the SMH Trustees.

Candidacy Statement of Ben Jones

We have all seen the erosion of trust in our institutions and lamented the clear crisis in America's historical understanding. Whatever your views on the state of our electoral politics or the political issues of the day, the primary job of a Trustee is to do everything possible to foster trust and confidence in the result of our professional labor. Whether it is K-12, college students, fellow scholars, or interested readers in the general public, we need to demonstrate our commitment to history done well. Angela M. Riotto is a military historian, who specializes in the American Civil War era, prisoners of war, memory studies, and literary studies. She currently works as the historian for the Defense Security Cooperation Agency as part of the Brigadier General Charles Young Research, Analysis, and Lessons Learned Institute. Before joining the Young Institute in March 2024, Dr. Riotto worked with the Office of the Secretary of Defense Historical Office. Prior to that, she taught as an assistant professor of military history at the U.S. Army Command and General Staff College in Fort Leavenworth, Kansas. Before joining the faculty at CGSC, Dr. Riotto worked for Army University Press's Films Team making documentaries to teach U.S. Army doctrine and military history. While there, she researched, wrote, and directed three films—OIF: The Drive to Baghdad, OIF: The Fight for Baghdad, and Okinawa 1945: Planning Operation ICEBERG—and wrote the script for the second Okinawa film—Okinawa 1945: Typhoon of Steel. To produce these films, Dr. Riotto interviewed dozens of veterans, attended reunions, as well as traveled to Okinawa to perform archival research and terrain reconnaissance. Dr. Riotto has also published numerous book chapters, journal articles, book reviews and encyclopedia entries, and presented her work at scholarly conferences across the country and abroad. She is currently working on two book manuscripts, Beyond the Prison Pen: Union and Confederate Former Prisoners of War and their Narratives of Captivity, 1861-1930 and The Life and Legacy of Robert Smalls.

With experience in civilian academia and professional military education, along with service in several historical organizations, I am well-equipped to contribute to the Society for Military History as a trustee.

Nicholas Evan Sarantakes is a historian of the World War II and Cold War periods and a full professor at the U.S. Naval War College. He received his BA from the University of Texas, where the undergraduate teaching of Robert A. Divine convinced him to go to graduate school. He subsequently earned a MA from the University of Kentucky, working under the direction of George C. Herring, Jr., and a Ph.D. from the University of Southern California, studying with Roger Dingman. All three degrees were in history. He taught for nine years at Texas A&M University—Commerce and received tenure. During that period, Sarantakes held visiting positions at the Air War College and the University of Southern Mississippi. He was at the U.S. Army Command & General Staff College before joining the Naval War College faculty. He is the author of six books and focuses on the strategic level and joint operations. His seventh book will be on the battle of Manila. He has won five writing awards and three teaching awards. His current research is on the World War II home front. He was the chair of the Paul Birdsall Book Prize Committee of the American Historical Association, He is also the editor of the "War on Screen" series for the University Press of Kansas. He has lived in Korea and the United Kingdom, and has done research in all 50 states and six foreign countries.

I believe the Society for Military History is one of the strongest and most robust organizations in the history business. The key to the success of the SMH has been the wise management of its financial resources and a well-functioning governing structure. The main job of the future leadership is to maintain these elements as academia faces some serious issues: the surplus of Ph.D.s, and declining undergraduate admissions. The organization has real strengths to face these problems. The SMH is international in scope. Although it is primarily based in the U.S., it has held its annual meets outside the United States several times and has had a foreign scholar as its president. Recent conference programs show that roughly 20 percent of the participants are employed outside the United States. The SMH also embodies professional diversity: roughly a third of its members hold positions outside of academia. The Society has been proactive in addressing the status of the subfield with the white paper "The Role of Military History in the Contemporary Academy."

As a trustee, I would hope to continue this pattern with initiatives that would be nothing more than small adjustments to existing programs: doing mock interviews for new Ph.D.s at the annual meeting, seeing more historiographical essays in the *JMH*, creating teaching awards, sponsoring a study on military history course enrollments, doing some fund raising for the summer seminar, and/or helping participants at the seminar learn how to incorporate staff rides, war games, and simulations into their curriculum.

Biographical Paragraph

I am a scholar of U.S. military history, of women's and gender history, of the history of U.S. foreign relations, and I have extensive experience in academic administration and advocacy. As both a historian and a higher education leader, I find that those identities reinforce each other more than they conflict. I went to graduate school because I wanted to work on intellectual problems; it has been a joy of my professional journey to connect and collaborate with colleagues who share that desire, whether it be in the classroom, in research, in public engagement, or in administration. While most of my time is not spent preparing lesson plans or parsing archival texts, I draw on my historian's training every day. When I synthesize information for different audiences or when I sift through stakeholder feedback, I draw on my skills of excavating the contours of scholarly debates, of meeting students where they are in the classroom, of connecting evidence and argument in order to clearly communicate.

As someone who was in graduate school during the Great Recession and worked for many years leading a national initiative exploring the value and purpose of a PhD in history, I believe strongly that newly minted graduates, be they PhDs or MAs, should not have to choose between the values that brought them to graduate study and reasonable compensation. Similarly, I believe that historians of all career stages are enriched by the pursuit of meaningful work, whatever that means to them.

Candidacy Statement

In some sense, I have been an ambassador for military history ever since the SMH made me feel welcome as a graduate student, more than a decade ago. Since then, the SMH has been a touchstone of my scholarly development. As a past recipient of the Weigley Travel Grant and an honorable mention for the Coffman Prize, I know first-hand how important grants and awards can be to supporting and encouraging early career scholars. I know it will continue to nourish and sustain me, and others like me, throughout my career.

Working at the American Historical Association for eight years gave me insight into how scholarly associations like the SMH support the work of scholars and students. My career as an administrator, at the AHA and at Michigan, has given me experience working across organizations, listening to constituents with widely varied points of view, and a broad, yet nuanced, understanding of the higher education landscape. As the research and teaching enterprise of higher education is under threat, with history itself sometimes a political football, it is more important than ever to argue for the value of history and the humanities. In a world where conflict can feel omnipresent, I think the insights of military history can be especially valuable. Serving as a trustee for the SMH would allow me to give back to an organization that has supported my scholarly and professional journey and to help argue for the value of military history in the various arenas SMH members inhabit.

Dr. Robert "Bob" Wettemann, Jr. is an Associate Professor of History at the United States Air Force Academy. He holds a B.A. with Honors in History from Oklahoma State University, and M.A. and Ph.D. degrees in History from Texas A&M University. He is the author of Privilege vs. Equality: Civil Military Relations in the Jacksonian Era, 1815-1845 and numerous articles and book chapters on U.S., military, and public history.
